Conditions of Entry

1. This competition will be conducted under EFA rules.
2. Horses are limited to two consecutive levels. No horse may be entered in more than three tests.
3. This competition will have prizes to third place and ribbons will be awarded to 6th place. Catering will be available.
4. Entry fees must accompany entries and may now be paid by internet banking. If you choose to use this option **the receipt MUST accompany the entry form to be accepted.** Enter the riders name and competition date as the reference, eg LPugh12Feb06. NCEC's account details are:-

5. Competitors MUST pay a \$20 levy if they are NOT a member of the EFA, NCEC or an EFA Affiliated Club. **Proof of membership with an EFA Affiliated club MUST be provided with the entry form.**
6. **Late entries** will only be accepted at the discretion of the club. **ALL late entries will incur a late fee of \$10 per test in addition to the usual fee.**
7. EFA Disclaimer Forms MUST be completed and submitted with the entry form if you are a member of the EFA, NCEC or an EFA Affiliated Club. Non-members MUST also sign a non-member waiver, which must be submitted before riding on the day. (*Member and Non-Member waivers can be obtained off the NCEC website*).
8. **No refunds will be made after the closing date for entries.** The club will refund 50% of entry fees when presented with a veterinary or medical certificate within 48 hours of the competition.
9. Grading points **MUST** be included for all events. Please ensure that for all official tests both horse or pony and rider are **current members of the EFA.**
10. **Bridle numbers are compulsory for all official tests. Please supply your bridle number on the entry form.**
11. All competitors are required to wear an **AS/NZS 3838 1998** or **EN 1384** or **ASTN F1 163** helmet at all times when mounted. Failure to comply with this ruling will result in elimination.
12. NCEC Inc. is not responsible for any damage, loss, illness, injury, or accident to persons, animals or equipment.
13. The organising committee reserves the right to alter, amend or cancel any section of the program.
14. A veteran horse is a horse aged 15years and over on the 1st August 2008. Note: this NCEC member's annual award can only be won once in a horse's lifetime.
